Master Plan for Aging Stakeholder Committees

Purpose: Stakeholder engagement is a key component of California's <u>Master Plan for Aging</u> (MPA) efforts. In alignment with the MPA, the below six committees provide recommendations and elevate issues related to older adults, people with disabilities, and caregivers.

Stakeholder Committees

1. <u>Alzheimer's Disease & Related Disorders Advisory Committee</u> (ADRD AC)

Established in 1988, the ADRD AC provides advice and assistance on program needs and priorities of persons with Alzheimer's disease and related dementias and their care partners. Committee members are consumers, family members, providers, and advocates.

2. CA Aging & Disability Research Partnership (CADRP)

CADRP was established in response to MPA Initiative #102 (2021-2022) which called for the California Health and Human Services Agency (CalHHS) to convene a nation-leading research partnership. Committee members are experts in aging and disability research from academic institutions, government, and philanthropy.

3. CA Elder & Disability Justice Coordinating Council (EDJCC)

EDJCC was established in response to Master Plan for Aging (MPA) Initiative #93 (2021-2022) which called for the creation of a statewide council to increase coordination and develop recommendations to prevent and address elder abuse, neglect, exploitation, and fraud. Committee members represent government and stakeholder organizations with resources and expertise related to elder and disability justice.

4. Disability & Aging Community Living Advisory Committee (DACLAC)

DACLAC, originally established in 2005 as the Olmstead Advisory Committee, advises CalHHS on community living policies and programs, such as long-term services and supports, transportation and housing, and employment, to advance to advance inclusion, integration, and equity. Committee members are consumers, family members, providers, and advocates.

5. Equity Advisory Committee on Aging and Disability (EACAD)

In 2020, the Equity Work Group (EWG) was formed to apply an equity lens to the MPA's development, implementation, and evaluation. In 2023, the committee was renamed the EACAD to continue this role. Committee members reflect the diversity of all older adults, people with disabilities, and family caregivers, ensuring representation from priority populations and historically underserved communities.

6. Implementing the MPA in CA Together (IMPACT) Advisory Committee (IMPACT)

Established July 2021, IMPACT advises CalHHS on the implementation of the MPA, focusing on accountability, outcomes, and continuous improvement towards the MPA's Five Bold Goals for 2030. Committee members represent diverse areas of expertise and experience in aging, disability, and racial justice programs, operations, services, and policy.
